LIVSMART 360 MEMBER AGREEMENT & TERMS OF ENROLLMENT

1. As a LiveSmart 360 Member, I acknowledge I am an independent contractor and not an agent or employee of LiveSmart 360. I understand I will not be treated as an employee for federal or state tax purposes. I acknowledge that I am not guaranteed any income, profit, or success, and that my signature below certifies that neither LiveSmart 360 nor my Sponsor has made any claim of guaranteed earnings or undocumented claims of anticipated earnings. Success or failure as a Member is strictly dependent upon individual time and effort. I acknowledge my participation in network marketing and LiveSmart 360 (the "Activity") is entirely voluntary and involves the financial risk and costs associated with any personally owned and operated business. I expressly assume all risks and costs associated with the Activity.

2. I agree not to misrepresent the capabilities of any LiveSmart 360 product. I further agree not to create any materials describing LiveSmart 360 products, test results, or product comparison literature unless authorized or previously approved in writing by LiveSmart 360.

3. I agree that all my advertisements must be factual and non-misleading. Any advertisement promoting or representing employment, salaried positions, management positions, hourly wages, or guaranteed income is prohibited. I agree to comply with LiveSmart 360's guidelines for advertising and will always disclose I am promoting a self-employment, 1099 income, or an "own-your-own-business" opportunity.

4. I acknowledge and agree that the LiveSmart 360 Compensation Plan is based upon the sale of LiveSmart 360 products and a Member will not be successful merely by sponsoring other Members without regard to retail product sales. I agree that when using examples to illustrate how the Compensation Plan works I agree not to make any income claims or projections that state or promise any specific amount of compensation a prospective Member may earn, whether orally or in writing, to other Distributors or prospective Members.

5. I acknowledge and agree that I may be terminated or disciplined for any violation of this Member Agreement and Terms of Enrollment, Compensation Plan, Policies and Procedures, committing unfair or deceptive trade practices, or any other violation of state or federal law. I agree that I have read all provided written materials before selling any LiveSmart 360 product.

6. I acknowledge and agree that with every order of new product, I must certify that not less than 70% of all previously purchased product has been personally consumed or sold and must identify what portion of the product was sold and what portion was personally consumed. LiveSmart 360 will not repurchase products or issue refunds on products certified as having been personally consumed or sold. Falsely representing the amount of product sold or consumed in an attempt to circumvent this requirement may be grounds for termination.

7. I understand that the initial term of the Member Agreement is one year from the date of its acceptance by LiveSmart 360. Members must renew their Member Agreement each year by paying an annual renewal fee of USD \$30 within 30 days of the anniversary date of their Member Agreement. This is an automatic renewal and will remain in effect until the Member notifies LiveSmart 360 in writing that they wish to terminate themselves as a Member or until the Member's business is terminated for inactivity or misconduct. I acknowledge that this Agreement must be fully executed and complete hard copies must be on file with LiveSmart 360 before any commissions will be paid on my distributorship and my distributorship may be terminated at the discretion of LiveSmart 360 if any of these pages has not been submitted fully executed within seven (7) business days of the date of Agreement.

8. I understand that no product purchase is necessary to become a LiveSmart 360 Member. I understand I may terminate or modify my Order Assurance Program at any time. I further understand I am under no obligation to make any further financial investment to become a LiveSmart 360 Member. I also understand any successful retail business will incur business expenses beyond the purchase of product. All Members are required to pay a non-commissionable USD \$14.99 monthly website hosting fee. (Not required in North Dakota.) The Member Starter Packs and websites are sold to assist the efforts of each new Member with continued training and sales support.

9. I understand if no personal sales volume is generated for 60 days, this Agreement will automatically terminate, and all business volume and any future commissions and bonuses will be forfeited. I understand I may re-enroll in a new position after six months of not generating personal sales volume by submitting a new Member Application and qualifying with at least 100 BV in product orders. Once terminated, the Member's business will not be available for sale or transfer.

10. I understand that should I wish to terminate my position as a Member, I must notify LiveSmart 360 in writing. At such time, any salable product that has shipped within 60 days of the termination date may be returned to LiveSmart 360 for a refund equal to 90% of the original purchase price, less any commissions or bonuses paid, less the 70% sold or consumed (as certified in reorders). All returns must have a Return Merchandise Authorization (RMA) number. The RMA number can be obtained by calling LiveSmart 360 Support at 941-371-1010. Perishable items, such as food or certain types of skin care products, will not be refunded after 30 days from date of purchase. In any state in which a specific buyback requirement has been enacted that may vary from the foregoing, LiveSmart 360 shall repurchase products and sales aids in accordance with any applicable statute or regulation.

11. I acknowledge and agree that in order to maintain a competitive marketing system and to comply with changes in applicable laws, LiveSmart 360 reserves the right to change prices, company policies, products, company literature, and/or the Compensation Plan without prior notice.
